

I FILM AND AUDIOVISUAL LAW CONFERENCE

TERMS AND CONDITIONS

1. INTRODUCTION

- 1.1. Film And Audiovisual Law Conference (hereinafter: the Conference) will have its edition on April 30th and May 1st, 2022 in Espinho, Portugal.
- 1.2. The Conference is organized by FEST Associação Cultural (hereinafter: the Organization), a non-profit NGO developing work on film, media and education, registered at Rua 23 n.º 768, 4500-276 Espinho, Portugal.
- 1.3. Clintons is a promoting partner of the Film and Audiovisual Law Conference. All obligations relating to the organization of the conference and contractual or other relationship with attendees are with FEST Associação Cultural. Clintons shall have no responsibility for those aspects of the conference.
- 1.4. By registering for the Film and Audiovisual Law Conference you accept the terms and conditions applied to the service. It is the responsibility of the user to analyze all the information published here before proceeding with the registration. The Organization reserves the right to change the terms and conditions. These changes will be published on the official website and will be considered valid from that moment onwards.

2. CONFERENCE REGISTRATION

- 2.1. No booking will be considered valid until the Organization receives the total value of the registration.
- 2.2. The Conference registration will be available for purchase online between the **18th of February and 30th of April, 2022,** or until all places have been sold, whichever comes first.
 - 2.2.1. the "Early Bird" discount for the registration will apply within the period of the 18th of February and 1st of March, 2022;
 - 2.2.2. the "Regular" fare for the registration will apply within the period of the **2nd of March and 20th of April, 2022**;
 - 2.2.3. the "Late Fee" fare for the registration will apply within the period of the 21st of April and 30th of April, 2022.
- 2.3. Each badge is issued to one specific individual identified in the purchase order. The badge will be nullified if resold, transferred, or tampered with by anyone other than the Organization, and the Badge holder will be denied entry to the Conference Events.
- 2.4. Upon purchasing an Accreditation, the amount due must be paid within 48 hours of order submission, through the online payment option (PayPal) available through the service. If an applicant encounters any significant technical problem with the payment, it must be reported via email to filmlaw@fest.pt in order to discuss alternative payment methods. These situations will be dealt with on a case by case basis and the Organization reserves the right to not provide an alternative payment method.
- 2.5. If the purchaser wishes to receive an invoice, it must be requested within the first 30 days after making the payment. The invoice request must be sent via email to filmlaw@fest.pt and it must have the payment confirmation attached and contain the invoice details of the purchaser (name, postal address and tax / VAT number).



2.6. The participants are responsible for checking the veracity of the information during the registration and report any errors or mistakes as soon as possible.

3. COMPLAINTS AND REFUND REQUESTS

- 3.1. Accreditations cannot be exchanged, refunded or returned for any reason, unless the Conference is canceled or moved to another date. Please be advised that if the Conference is canceled or postponed, the Organization will not be responsible for any travel costs or other expenses.
- 3.2. If there is the need of any major alteration of the event, due to force majeure circumstances, the registration is valid for the new dates. In this case, if the participant desires to be refunded, it must be requested no later than 10 days after the date change communication. In no case will there be reimbursement of any travel or accommodation expenses to participants due to force majeure changes.
- 3.3. The Organization is not responsible for any compensation or refund in case of absence of the participant due to any situations out of the sphere of control of the Organization, such as war or threat of war; riots; civil unrest; industrial dispute; airport shutdowns; flight cancelations; terrorist activity; natural disaster; nuclear disaster; fire, adverse weather conditions; or similar situations.
- 3.4. No refunds are offered in the event of participants being unable to attend due to any change caused by personal circumstances, disorder or illness.
- 3.5. The Organization reserves the right to refuse entry and reimbursements in case of abusive behavior, physical and psychological threats, drunk or disrespectful attitude from the participant. The same is applied if the participant tries to enter the event with any object considered as a weapon or with any illegal substance.
- 3.6. The Organization will not be considered responsible for the loss or destruction of private property of the participant, nor will it be responsible for any medical or hospital expenses in case of injury or illness inflicted during the event nor on its installations or in the city that is hosting the event. For this exact reason the Organization advises the participants to acquire health and travel insurance against all possible risks.

4. FINAL RESOLUTIONS

- 4.1. The Organization photographs, films and records the activities that take place during the Conference and its Events. The Organization and its Partners reserve the right to use, both in digital and printed format, the images, video and audio recorded during the event. When registering, the participant agrees to be photographed, filmed and recorded in this context, assigning the rights of their image to the Organization and its Partners.
